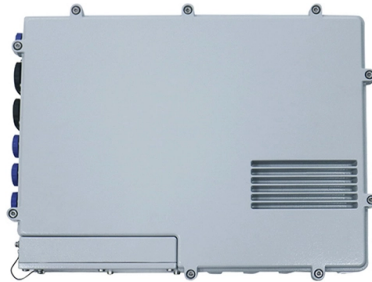


The Global Energy Interconnection proposal
